Mr. Dozier was taken to the Police Department and was read his statement of rights. by R/O and Mr. Dozier gave the following information.

Mr. Dozier said that he went to the residence to talk with his ex-girlfriend, Misty. He said that he was outside the bedroom window when he saw the spot light on the police car and he went through the window and hid in the closet.

Mr. Dozier said the only reason he went to the residence was to talk with Misty.

Mr. Dozier was booked for Criminal Trespass.

WITNESS SUMMARY
LARRY WIND

Larry responds to the call back on September 27, 1992. He enters the apartment and is advised, along with other officers, that Joe is in the closet. Joe is taken out of the closet by Sgt. Wind, at which point he is cuffed and then taken out of the house.

Sgt. Wind states that Joe Dozier gave him no problems, in fact, describes him as "docile". Sgt. Wind recalls to some effect, that they were talking that Joe and the girl at the apartment were boyfriend/girlfriend and there was question that the girl was pregnant and there was just a lot going on with this. He recalls that the mother was pushing this.

All indications, that based on the surrounding circumstances resulted in the discharging with the criminal mischief trespass charge.
