## WITNESS SUMMARY LARRY\_WIND

Larry responds to the call back on September 27, 1992. He enters the apartment and is advised, along with other officers, that Joe is in the closet. Joe is taken out of the closet by Sgt. Wind, at which point he is cuffed and then taken out of the house. Sgt. Wind states that Joe Dozier gave him no problems, in fact, describes him as "docile". Sgt. Wind recalls to some effect, that they were
